Applications – International Cooperation

Managing Authority of The Operational Program Technologies and Application for Competitiveness informs about the planned Call Applications – International Cooperation and provides preliminary information to applicants and those interested in applying:



Supported Activities

Industrial research and experimental development within the meaning of Article 25 of GBER, conducted in cooperation with at least one international partner whose expenses are covered by relevant regional or national programs of the partner countries.



The aid intensity

- Depending on the type of activity (industrial research / experimental development) and the size of the enterprise: 25 80%:
- Research Organizations: 85%.



Minimum and Maximum Grant Amount

The grant for the project is provided in a minimum amount of CZK 3 million and up to a maximum amount of CZK 50 million.



Eligible Applicants

- SME;
- Large enterprises with more than 3000 employees only in cooperation with SMEs (30% of Total Eligible Costs) or with SMEs and Research Organizations;
- · Research Organizations only in the role of a partner.



Supported territory

The territory of the Czech Republic outside the NUTS 2 Prague



Eligible Costs

- External services (contract research, R&D consulting services used for the purposes of the project, and other operating costs) up to a maximum of 30% of Total Eligible Costs;
- Personnel costs researchers, technicians and other supporting staff to the extent employed on the project;
- Costs of tools, instruments, and equipment acquired from third parties in the form of depreciation
 of long-term tangible movable property to the extent necessary and for the period during which they
 are used for the project, up to a maximum of 20% of Total Eligible Costs;
- Material and component costs;
- Flat-rate costs (additional overhead costs) in the amount of 15% of personnel costs.



Application Requirements

- Project plan, detailed budget;
- Form to verify the "Do No Significant Harm" principle;
- If relevant, partners' Compliance plans and draft cooperation agreement;
- A specific condition is an application to the international network IraSME or documentation
 of another mechanism ensuring the financing of foreign partners (from national or regional aid
 programs). A list of participating countries will be attached to the Call. The list can be expanded.



Additional Requirements

- 1) With the application for the aid:
 - a) International project plan (information about the whole project);
- b) Draft cooperation agreement with a foreign partner;
- 2) At the time of signing the Funding decision:
 - a) Statement of the foreign provider to approve the grant or its equivalent;
- b) Signed cooperation agreement between partners;
- 3) At the time of 1st request for payment:
- a) Signed Funding decision of foreign provider to grant the aid;
- 4) At the time of the last request for payment:
 - a) Information about the project implementation, outputs and total costs.
